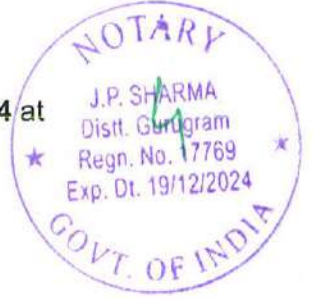

  - a. The monthly rent for the property is **₹4,000.00 (Four Thousand Rupees only)** per month.


